Preston Supply Briefing The twin-turboprop Trent 100-1666, which is operated by Belair International, is used to fulfil a range of services. Exelis has been working with the operator since the late 1990's to develop a number of systems to maximise the level of service the helicopter can provide. The example shown is an aircraft fitted with a system designed to provide a windscreen for the pilot. The images, supplied by Exelis, show the use of a green laser, which uses an IR LED source to make the laser green. The laser is integrated with a cooling device, which consists of a cooling fan and heat exchange plate, to reduce the heat from the IR LED. The cooling device is further integrated with a cooling supply pack, which is fixed to the flight deck. The laser is protected by the windscreen, which can be adjusted to match the windscreen area and shape. The key is activated by a lever operated by the pilot. The US is considering the approval of use of lasers on aircraft as a tool to be used by countermeasures personnel to counter missile threats. As guidance for their use of lasers on aircraft, the US Department of Defence, in the guidance published in September, stated: "reducing the potential for eye injury from laser hits is an important consideration in the use of countermeasures lasers on aircraft. Lasers are generally safe at typical laser exposure levels to the eye, provided a target protection means (such as a pinhole aperture) is used and correct eye protection is worn".

This matter is before the Court on the defendant's Motion to Suppress Evidence and Statements (Docket No. 14). The defendant was charged by indictment on February 26, 1985 with the murders of Jose Mercado on October 12, 1984 and of Maria Rios on December 4, 1984, and with the attempted murders of Rogelio Mercado and Pedro Cano on January 12, 1985. The defendant was also charged with numerous firearms violations arising from the illegal possession of numerous firearms and his use of a silencer on a gun which was used in the murder of Maria Rios. The Government moved for a court order authorizing it to conduct electronic surveillance over the telephone at the defendant's

residence. The Court authorized electronic surveillance over the defendant's telephone on March 12, 1985 at the Government's request and on March 14, 1985, the Government again applied for an order authorizing it to monitor the defendant's telephone. The defendant filed a motion to suppress the evidence obtained pursuant to the March 14, 1985 eavesdropping order on May 1, 1985. The defendant's argument before the Court is based on a claim that the Government failed to comply with 18 U.S.C. § 2518(1)(c) because the surveillance order did not sufficiently set forth the facts establishing that there was a likelihood that particular evidence of a crime would be obtained, and that more progress had not been made toward the goal of obtaining evidence of the commission of the crime. The defendant further argues that the Government failed to state that an investigative agency such as the F.B.I. or the Drug Enforcement Administration was conducting the investigation in question. Finally, the defendant contends that the surveillance order was not reasonably related to the offenses for which he was indicted. The Government argues that the surveillance order contained
